ALL OBLIGATIONS AND LIABILITIES FOR REPAIRS COVERED BY THE EXTENDED SERVICE AGREEMENT ARE THOSE OF THE SELLING DEALER AND NOT FIRST EXTENDED SERVICE CORPORATION.

WHAT TO DO IF REPAIRS ARE NEEDED: If your Manufacturer's New Vehicle Warranty is still in effect, contact the Selling Dealer. After the expiration of your Manufacturer's New Vehicle Warranty and if your vehicle is within one hundred (100) miles of the Selling Dealer, you must deliver your vehicle to the Selling Dealer at the address shown on the front of this extended service agreement. If your vehicle is more than one hundred (100) miles from the Selling Dealer, call First Extended Service Corporation for instructions before you deliver your vehicle to a repairing facility. You must authorize the repair facility to perform necessary diagnostic work so that the repair facility can provide an accurate estimate of repair. To ensure coverage under the terms of this extended service agreement authorization must be obtained prior to the repair.
